- 3. **From Darkness to Light (Conversion Narrative):** The central plot arc involves the protagonist's profound spiritual transformation.
- * **Description:** The story moves from her involvement with New Age practices and spiritual confusion to a dramatic and authentic Christian conversion experience.

- * **Excerpt/Reference:** "I had pursued the new age world until it pursued me with a vengeance. It was only then that I would give Christianity a shot. - 4. **Absent Parent/Parental Neglect:** The biological father is largely absent, and the mother, though present, is often emotionally unavailable or overwhelmed.
- * **Description:** The biological father leaves the family, and the mother, burdened by mental illness and life's demands, is frequently too preoccupied to provide adequate emotional or physical care.
- * **Excerpt/Reference:** "Mom and Dad never had much money... that resulted in Dad leaving for long enough periods that a foreigner had to be our caregiver." (p. 15). "Mom didn't experience hunger until she was an adult... She never realized how hungry her kids were..." (p. 24).
- 5. **Abusive Stepparent:** Both step-father (John) and step-grandmother (Peggy) are sources of severe abuse.
- * **Description:** John Herrin inflicts sexual and physical abuse, while Peggy, the step-grandmother, is emotionally manipulative, verbally cruel, and physically abusive.
- * **Excerpt/Reference:** "Around 1986, John started sexually abusing Becky, who was about eight." (p. 36). "I detested the burn of the wooden spoons she used to slap us if we didn't clean our plates or wash the dishes the right way." (p. 49).
- 6. **Spiritual Warfare (Literal):** The protagonist experiences direct, tangible encounters with malevolent spiritual entities.
- * **Description:** The author describes literal interactions with demons and spirits, including seeing their forms, feeling their presence, and experiencing their physical effects on her body and environment.
- * **Excerpt/Reference:** "The ghost was a disgusting, horrifying female with stringy, sparse white hair... She floated through the closed door and hovered in the air, her eyes fixed on me." (p. 5). "Demons sporadically hounded me daily and jerked me awake at nights." (p. 117).

- 7. **The Quest/The Pilgrimage:** The protagonist's life is framed as a significant spiritual journey, including a specific two-year mission assigned by God.
- * **Description:** God gives the protagonist a two-year mission to learn from Tim Tebow, which she explicitly labels a "pilgrimage," and her broader spiritual growth is consistently depicted as an arduous journey.
- * **Excerpt/Reference:** "I called it a mission or pilgrimage even though I was not physically going on a pilgrimage but rather staying put and simply learning from this footballer from afar." (p. 215). "The pilgrimage countdown was still in motion, and it was a time of accelerated learning, housekeeping, and tying up loose ends." (p. 309).
- 8. **Deceptive Appearance:** Characters and practices that outwardly appear benign or helpful but harbor hidden dangers or malevolence.
- * **Description:** John's attractive exterior hides his abusive nature, and various New Age practices seem harmless but lead to demonic oppression.
- * **Excerpt/Reference:** "John was a far bigger snake than the live ones he tossed back into the ditch after maiming them." (p. 38). "I didn't think that entailed anything demonic but simply that the crystals would possibly improve something..." (p. 123).
- 9. **Found Family:** The protagonist eventually discovers supportive and genuine community in unexpected places.
- * **Description:** After experiencing isolation and disappointment in early church experiences, she finds a sense of belonging and camaraderie in a theology group and a new church community.
- * **Excerpt/Reference:** "These are my people now, these fellow Christians." (p. 11). "I found a new church family that actually met in a public school auditorium, and it felt like the early church!" (p. 305).
- 10. **Childhood Trauma:** The narrative extensively explores the long-term, pervasive impact of early life abuse and neglect.

- * **Description:** The memoir consistently links the protagonist's adult struggles—such as depression, chronic pain, and trust issues—back to specific traumatic events from her childhood.
- * **Excerpt/Reference:** "Childhood trauma affects everything." (p. 12). "A deep empathic scar formed in me that day. It still itches when I think about it." (p. 18).

- 13. **The Outsider/Fish Out of Water:** The protagonist consistently feels disconnected or out of place in various environments.
- * **Description:** Throughout her life, she experiences a persistent feeling of not belonging, whether due to frequent moves, social awkwardness, or spiritual differences from those around her.
- * **Excerpt/Reference:** "But I had felt like a foreigner my whole life, so when I was an official foreigner, the 'extraness' of it made it hard to grasp." (p. 76). "I didn't belong, but the

rent was affordable. I walked at all hours to a local beach or a drugstore because it was the only light shining through the night." (p. 186).

- 14. **Shared Trauma:** The protagonist finds deep connection and understanding with others who have also experienced suffering.
- * **Description:** She forms bonds with individuals like her sister Becky, half-brother Sam, and ex-boyfriend Andrew, recognizing their shared experiences of trauma, which provides validation for her own pain.
- * **Excerpt/Reference:** "It's freeing when your brother/friend confesses his similar feelings, and my brother was "the man in my life," a safe, loving support." (p. 88). "I hate to say someone needs experience to understand something, but sometimes it's true, isn't it? Sure enough, Andrew theorized..." (p. 108).
- 15. **Spiritual Shortcuts/Gimmicks (New Age):** The protagonist's initial attempts to find quick and easy spiritual solutions outside traditional faith.
- * **Description:** She initially turns to New Age practices like "energy healing," reiki, and crystals, seeking immediate relief for her chronic pain and spiritual emptiness, only to find them deceptive and harmful.
- * **Excerpt/Reference:** "Unwittingly, I pushed through the surface and discovered energy healing, a new age concept combining science (supposedly) and spiritualism." (p. 98). "Reiki and crystal healing were introduced to me there, but I drew the line at Kundalini yoga..." (p. 122).
- 16. **Symbolic Rebirth/Baptism: ** Beyond the literal act, experiences of profound spiritual cleansing and new beginnings.
- * **Description:** The narrative includes her adult water baptism, but also portrays metaphorical "baptism in tears" and being "bathed in the blood of Christ" as moments of significant spiritual transformation and a new start.
- * **Excerpt/Reference:** "Baptized in my own tears, the pain hit with full force, but then I started to feel life." (p. 236). "If I was the first born again in the family... I wanted to know and experience as much as I could because I'd be leading the way for those who came after me." (p. 296).

- 17. **The Good Book (and its Interpretations):** The Bible is presented as ultimate truth, but its meaning is often confused or misused by others.
- * **Description:** The Bible is a central source of guidance for the protagonist, yet she encounters various interpretations, legalistic applications, and even instances where people seem to worship the book itself rather than the God it reveals.
- * **Excerpt/Reference:** "I wanted to be biblically anchored while Spirit-led like Abraham, the apostle Paul, and Enoch even more! I have no idea what to do, God, help! What am I supposed to do? Is this my mind, or is it you?" (p. 261).
- 18. **The Innocent Victim/Scapegoat: ** Younger siblings, and particularly Becky, suffer disproportionately due to their vulnerability or protective instincts.
- * **Description:** Miah and Sam are depicted as innocent children whose suffering deeply impacts the protagonist. Becky takes on the role of a scapegoat, enduring more frequent abuse, believing it protects her younger siblings.
- * **Excerpt/Reference:** "As an adult, she said, 'I thought everyone liked John... I knew the things he did hurt, but I thought, 'If he is doing these things to me, he isn't doing this to the younger kids—and it hurts.'" (p. 28).
- 19. **The Mirror Character:** Individuals who serve to reflect the protagonist's own flaws, struggles, or potential for growth and self-awareness.

- * **Description:** The protagonist receives explicit guidance from God (directly, through angels, and Scripture) and from human mentors. Tim Tebow serves as a distant role model, while figures like Doug and Darrell provide direct, personal counsel.
- * **Excerpt/Reference:** "God sent me my own Hosea figure. The Lord selflessly thought of whom I would sincerely accept as a friend, would respect as a mature brother in Christ, and someone with whom I would be truly comfortable because I was going to be spending plenty of time learning from him." (p. 219). "The head of my troop for this mission—writing my testimony—would be Darrell, a house painter and New Testament scholar." (p. 7).
